

Who pays what - Wangapeka Education Trust

These tables set out the policy adopted by the WET Board for who pays for what in terms of accommodation, food, and (for Category 1 retreats) cook's fee.

Categories

Co-teachers - when 2 or 3 people share the teaching more-or-less equally. Co-teachers must be identified when the course is first proposed and identified in advertising for the retreat. A main teacher with 1 or 2 assistants is not a co-teaching situation.

Support person/assistant - a person who supports or acts as an assistant to a teacher or to co-teachers. Only one per retreat.

Cook - if paid, the cook is paid for everyone except the teacher (or one teacher, if there are co-teachers), and the caretakers.

Guests - these are rare and are identified by the Board on a case-by-case basis (eg, Pa Ropata, Brandon).
